All goods sold shall be at the customer's risk immediately upon delivery. We acknowledge and agree to the conditions above and over and hereby accept liability with Artisan Foods for all outstanding debts and will PERSONALLY be responsible for, and pay any expense including interest and court fees in obtaining payment of overdue accounts. Dishonoured cheques will incur a \$35 fee and further defaults will result in COD basis or court action being taken.
